

Quota Transfer Highlights

As a grower, you are responsible for understanding the parameters of the quota transfer mechanism and the regulations that apply to it. Below is a list of parameters that anyone transferring or having quota transferred needs to be aware of. This list is not exhaustive and provides only the highlights. If you have further questions, please contact the office at (403) 223-1110 as well as read the appropriate policies provided by ASBG.

- 1. All Quota Transfers are Subject to Board Approval. Transfers will be handled at the next regular scheduled board meeting.
- 2. Quota must remain in the same growing area. This is identified in the license number provided by the ASBG office.
- 3. No grower can exceed the 4% (1,356) acre maximum. This includes any leased quota. Please refer to the maximum quota policy for clarification.
- 4. All growers must be actively engaged. For the definition of actively engaged, please refer to the actively engaged policy.
- 5. Quota is only eligible to be transferred every three years. (In some cases where extenuating circumstances prevail, the board may allow a transfer within the three-year period, but that is at the Board's discretion.)
- 6. All transfers are subject to a \$300 administration fee. This fee must be paid prior to the transfer being brought forth to the Board for a decision.
- 7. ASBG commits to a service standard of processing transfers within 14 business days of the board approving the transfer. All information and forms regarding a transfer must be submitted 7 business days in advance of the regular scheduled board meeting.
- 8. The ASBG Board and office can not be held responsible for any monetary transaction that parties have entered as per the disclaimer below.
